Intro: In spite of the fact that Puritans left England for religious freedom, they had a tendency to treat dissenters harshly and be intolerant of those not espousing or upholding their beliefs. In this webquest, you will explore the ways in which the Puritans quashed this dissent through three cases: Anne Hutchinson, Roger Williams, and the Salem Witch Trials.
